



ADHESION TO THE ROMAN ROADS HERITAGE COOPERATION NETWORK – ITER ROMANUM

FOURTH: The Roman Roads Heritage Cooperation Network - Iter Romanum is a cultural, tourism, heritage and educational cooperation project aimed at developing an itinerary based on the Roman heritage linked by Roman roads, a network of more than 300,000 kilometers of roadway branching out in all directions, connecting the capital of the empire, Rome, to the rest of its territories, from large cities to small towns and villages.

FIFTH: Joining as a collaborating partner of the Roman Roads Heritage Cooperation Network - Iter Romanum does not involve any monetary consideration.

SIXTH: As a collaborating partner of the Roman Roads Heritage Cooperation Network – Iter Romanum, (NAME OF THE ENTITY) will have a voice within the association, but no vote.



SEVENTH: Adhesion to the Roman Roads Heritage Cooperation Network - Iter Romanum as a collaborating partner will take effect as of the day of its signing and will have a duration of one year, tacitly renewable by the parties for annual periods.

Either party may dissolve this partnership by notifying the other party, in writing, three months prior to the date on which they wish to terminate said partnership or, if applicable, prior to its extension.
